4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

Technical Measures: Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent dispersion of dust. Wash hands and face thoroughly after handling. Use a local exhaust if dust or aerosol will be generated.
